2021 Fall Board Meeting Minutes - Zoom - Oct. 16, 2021

President Jacqueline Shellman welcomed everyone to the meeting and announced Sara Ayala as timekeeper, Margherita Clemento as parliamentarian and Neale Steiniger as credentials chair. Parliamentarian Margherita Clemento was asked if board members had standing rules. She reported that the standing rules were emailed and also available the state website. No objections were raised to dispense with reading of the standing rules, therefore standing rules were adopted.

President Shellman presented the meeting agenda and announced changes. The amended agenda was adopted.

Membership Chair Renee Cerullo: There are 314 members; We are adding new members, but losing members faster; Robin Bridson added that to promote membership, fresh marketing materials and press releases will be created, online activities and contests will be introduced to spur friendly membership competition among chapters, and a cafeteria of successful chapter marketing and promotional ideas will be posted for others consider.

Personal and Professional Development Chair Robin Allen: Reiterated the program is the only mentoring program of NYSWI and will continue to reach out to gain more participants.
