

8th Annual Conference Holiday Inn Binghamton Downtown June 2-4, 2017

Call to Order:

President Theresa Fazzolari called the meeting to order on Friday June 2, 2017

President Elect Debra Carlin lead the assembly in the Pledge of Allegience.

President Fazzolari asked for a moment of silence for members who have passed and reminded members that a Memorial Service will be held Saturday, June 3rd at 8:30 am in the Binghamton room. She recognized the timekeeper Janet Carey, pages Shirley Felder and Frida Hooyberg, Parliamentarian Margherita Clemento, and Acting Credentials Chair Linda Provo.

Adoption of Conference Book:

A motion was made by Mary Stelley and seconded by President-Elect Debra Carlin that the **Conference Book**, containing the official Schedule and Agenda for this weekend's conference be accepted, with the President empowered to make changes in the Business Agenda and Schedule as may be required to expedite the business of the Conference. **The motion carried**.

President Fazzolari thanked Robin Bridson for preparing the Conference Book.

Adoption of Conference Rules:

The Chair recognized Parliamentarian Margherita Clemento for the reading of the rules on page 2 of the Conference book. Abiding by the wishes of the assembly the rules were not read, and hearing no objections, the Chair declared the **Conference rules accepted**.

Registration: Chair Linda Provo was called on for the Registration report which indicated 36 members were registered from 11 chapters., and a quorum was present. Members must be registered before the close of the second business session tomorrow to be eligible to vote in the election of officers. The Registration report will be attached to the minutes

Introductions:

After the officers introduced the dais, Past State Presidents, Region Directors and Assistant Directors, Standing Chairs and Vice Chairs, and Special Committee Chairs and Sub Chairs, President Fazzolari welcomed everyone to the 8th Annual State Conference of NYS Women Inc. The assembly was invited to "Celebrate the Member" to continue to move the organization forward and encouraged to attend the "Blizzard of Events" and "Leadership" workshops. The Chair thanked the Relaxation workshop presenters for coming and encouraged everyone to attend their workshop in the morning.

<u>Secretary</u> Susan Mager read the **actions of the Executive Committee** since the April Board meeting for informational purposes. The Chair reminded the assembly that all items of new business must be submitted to the Secretary on a motion form by the start of the second business session.

Ratification of Region Elections:

Debra Carlin, President Elect, introduced the newly elected Region Directors and Assistant Region Directors and invited them to step up in front of the dais.
