

Conference (on-site) Standing Rules

Standing Rules for Conference

- 1. All members shall keep registration badges in evidence throughout business and workshop sessions.
- 2. All items of new business, including motions, must be in writing and submitted to the Recording Secretary prior to the start of the business session.
- 3. All speakers shall state their name and the name of the Chapter to which they belong.
- 4. When speaking to a motion, each speaker will declare if speaking in the affirmative or the negative and will be limited to two minutes.
- 5. A speaker cannot speak twice to the same motion until everyone else wishing to speak has done so.
- 6. The privilege of the floor may be given to a guest by majority vote.
- 7. All guests granted permission to attend the meetings should sit in seats assigned by the Conference Committee.
- 8. Debate on each subject will be limited to ten (10) minutes inclusive of points of information, etc.
- 9. There shall be a timekeeper for each business session.
- 10. Ballots resulting from all elections at the conference shall be destroyed at the close of the conference.
- 11. The minutes of this conference shall be approved by the Immediate Past State President and the Parliamentarian.
- 12. The current edition of *Robert's Rules of Order, Newly Revised* shall be the parliamentary authority for the conduct of business.
- 13. Reports not included in the Program Book will be placed on a separate table in the rear of the meeting room for attendees to pick up. Pages will not be asked to distribute late reports.
- 14. The President is empowered to make changes in the Business Agenda and Conference Schedule to expedite the business of the Federation.
- 15. All reports of the State Conference that require a vote by the voting body must be distributed to the body before the First Business Session.
- 16. Anyone making an oral addition to a written report will be limited to three (3) minutes.
- 17. All personal communication devices such as, but not limited to, cell phones and pagers must be put on silent mode during business sessions, hearings and workshops, as well as other appropriate times such as guest speaker presentations. A \$5.00 penalty will be assessed for each violation; said penalty will be donated to NIKE.

	I collected board and conference registrations, registration income, ad book income, and President Purse income. Stipend checks were distributed for Fall and Spring Board and I'll be ready to distribute them for Annual Conference.
	Due to our QuickBooks being so out of date, it was impossible to transfer from Patti's laptop to mine. We have invested in QuickBooks Online and needed to start from scratch. Questions asked of the panelists covered a wide range of issues, such as the origin of complaints, legal jurisdiction, referrals to Family Court, referrals to Fearless for time-limited safe housing and a myriad of support services and follow-up services by the SC Department of Social Services.
	Members of the panel referenced programs that have recently begun, as well as those that are in the process of being developed to meet the many needs that exist. The group of contributors agreed that Domestic Violence and its many related problems and needs are complex and complicated and in need of funding and community involvement. The victims, adults and children, are severely impacted and often need long-term support.
	The Professional Women of Sullivan County plans to expand its advocacy on this topic and others in the future. It hopes to revisit issues related to Domestic Violence in the future to increase awareness of the successes of current programs, as well as those of proposed projects.

State should only focus on marketing to increase membership and advocating for women – taking noticeable action on issues. Personal and Professional Development as well as other activities such as Business Women's Week and Women's History programs should be left to the local chapters. Simplify.

Most of the discussion centered around Option 2, as members agreed that Options 1 and 3 were off the table. There were questions about Option 2, regarding the annual State Conference. All wanted a hybrid meeting (zoom plus in-person) due to cost considerations. The State budget should cover costs for zoom coverage. Again, the emphasis was on more representation of local chapters, more accountability from the State Organization and emphasis on ADVOCACY and women's issues and needs. What can we offer newer/younger members?

In addition to the above, it was noted that Region 8 has not received region dues collected by the state in several years. The Region is requesting that this matter be addressed immediately.
