# **CONFERENCE STANDING RULES**

- 1. All members shall keep registration badges in evidence throughout business and workshop sessions.
- 2. Main motions must be in writing and handed to the Record Secretary.
- 3. All speakers shall state their name and the name of the local to which they belong.
- 4. When speaking to a motion, each speaker will declare if speaking in the affirmative or the negative and will be limited to two minutes.
- 5. A speaker cannot speak twice to the same motion until everyone else wishing to speak has done so.
- 6. The privilege of the floor may be given to a visitor by majority vote.
- 7. All guests granted permission to attend the meetings should sit in seats assigned by the Conference Committee.
- 8. Debate on each subject will be limited to ten (10) minutes inclusive of points of information, etc.
- 9. There shall be a timekeeper for each business session.
- 10. Ballots resulting from all elections at the conference shall be destroyed at the close of the conference.
- 11. The minutes of this conference shall be approved by the Immediate Past State President and the incoming Executive Committee.
- 12. The current edition of *Robert's Rules of Order*, *Newly Revised* shall be the parliamentary authority for the conduct of business.
- 13. Reports not included in the Program Book will be placed on a separate table in the rear of the meeting room for attendees to pick up. Pages will not be asked to distribute late reports.
- 14. The President is empowered to make changes in the Business Agenda and Conference Schedule to expedite the business of the Federation.
- 15. All items of new business must be submitted to the Recording Secretary, in writing on a Motion Form, prior to the start of the Third Business Session.
- 16. Anyone making an oral addition to a written report will be limited to three (3) minutes.
- 17. All reports of the State Conference that require a vote by the voting body must be distributed to the body before the First Business Session.
- 18. All personal communication devices such as, but not limited to, cell phones and pagers must be put on silent mode during business sessions, hearings and workshops, as well as other appropriate times such as guest speaker presentations. A \$5.00 penalty will be assessed for each violation; said penalty will be donated to *NIKE*.

# Much more work to be done:

- ■Establish a membership process that allows credit card payment for renewing and new member dues.
- '■Strategic planning: The 8 region plan is a reality, the next step is establishing our structure. What should the size of the BOD be, should all Board positions be elected? Are some aspects of the board meetings "time wasters"?
- ■Define what our advocacy priorities are (i.e. mandated issues), and take action. Note: Jilly's Law is being brought forward by Niagara Frontier Chapter/Region 8. This is a bill that passed in the NYS Senate on April 18th and has not passed in the NYS Assembly. Jill Russell Cahill, a victim of domestic violence, was murdered by her husband who was out on bail after having brutally assaulted her. This bill adds criteria for determining whether to issue an order of recognizance or bail; grants court discretion to order a defendant on bail to submit to the use of an electronic monitoring device; allows the court to consider any record of violations of court orders; authorizes the court to consider any history or pattern of threats or violent acts against the alleged victim or towards others; provides that if the court denies bail, it shall place its reasons on the record."
- ■Public Relations: respond to timely issues with statements from the organization/post on website/share with local media outlets throughout NYS.
- ■Professional and Personal Development: What can we do to promote the programs? What are the Chapters and Regions needs how can we make the programs worthwhile to participate in?
- ■Youth Leadership-provide a program guide to each Region to enable Regions and Chapters to present the program in their own communities, rather than at a State BOD meeting.

2012-2013 Presidents Theme: is it "Women Helping Women", "Building Powerful Women", "The Challenge of Change or even "Back to Basics"? No, I personally do not have one "theme" for 2012-13. If anything, this year will be "Your Year" to do what your Chapter/ Region does best in your community. ## Goals for 2011-2012:

Instead of doing a single event in April that less than a handful of our members ever attend, I wanted to get all of our members to lobby more regularly by being an armchair warrior (lobbying from the safety of your own home without road tripping to Albany).

## Action Plan:

Concentrate our activities on sending out notices to the members to get them to take action year around. Regularly distribute materials to the full leadership (through state leaders, chairs and DDs) requesting that the material be distributed to the members to take action. Temporarily rename the committee the Lobby (every)Day Committee.

## **Accomplishments:**

Fifteen girls attended the Youth Leadership Conference. A big thank you to the following helpers: Lucy Argenzia, Sara Ayala, Jim Ayala, Jeanne White, Karen Hunter, Hillary Egbertson, Kristen Stewart, Patricia Valtros and Eileen Howe Bird. A special thanks to Kristen Stewart for her hard work and going the extra mile making this the best YL event to date.

On Friday evening, the girls were treated to hair and make-up tips to in preparation of an upcoming interview. On Saturday, the girls participated in the BPW/Indiana Reality Store. The Reality Store is financial simulation where high school students choose careers and make decisions about their budgets and lifestyles. The activity an effective way for students to learn about personal accounting, financial responsibility and life choices while interacting with business people. Students receive "paychecks" and random information regarding individual marital status and parenthood. They also instructions on making purchases.

Stations include taxes, financial institution, real estate, apartment rentals, apparel, car dealer, credit cards, day care, gasoline, charities, memberships, entertainment, "life unexpected realities," gasoline, taxes, grocery store, insurance, investments, household products, phone company, cable TV and utilities. Students visit the stations, write checks and balance their checkbooks. Upon completion, they assess their decisions and financial status. Some girls needed to get a part time job in addition to their full time job just to make ends meet.

In advance of the event, the girls identify their future careers and randomly select their marital status (single, widowed, married or divorced) and number of children, which could be 0-4. In addition to visiting the various booth, our charities person continues to ask the participants if they wanted to donate to various worthy organizations, ranging from the Red Cross to the Girl Scouts.

After the Reality Store, Sara Ayala led a segment on Resume Writing and Interview Techniques. She asked them to compare their resumes to a standard resume and discussed the elements of a good resume compared to an outstanding resume. She provided worksheets that identified action words for the girls to consider for their resume as well as format guidelines.

Following the resume presentation, Patricia Valtos, a member of the Rome Chapter

who lives in PA and works for a judge presented a segment regarding relevant questions and how to handle illegal questions during an interview. She explained the reality of getting a DWI or any drug related arrest and its impact on one's career or college application.

Another segment included the social media aspects discussing the use of a normal email address instead of using something like partygirl.com, or putting pictures on face book showing girls on Spring vacation "partying". We had the girls shake hands and displayed the proper handshake.

In the afternoon, the participants attended a workshop all about the Interview, from what to wear, when to arrive, what to expect, what questions to ask and to remember to bring extra copies of your resume.






