Project: Equal Rights Amendment

US Senate: S.J.Res.1 – 117th Congress (2021-2022)

A joint resolution removing the deadline for the ratification of the equal rights amendment.

Sponsor – Senator Benjamin L. Cardin (D-MD)

Co-Sponsors:

Request all of the Chapter Presidents to ask their members to contact the Senators listed and ask them to support the S.J.Res.1 removing the deadline for the ratification of the equal rights amendment. Reference the fact that the House of Representatives has already passed this resolution.

Write a letter or note (do not use e-mail) and send copies to local papers and other interested groups in their community and to the Regional Directors.


